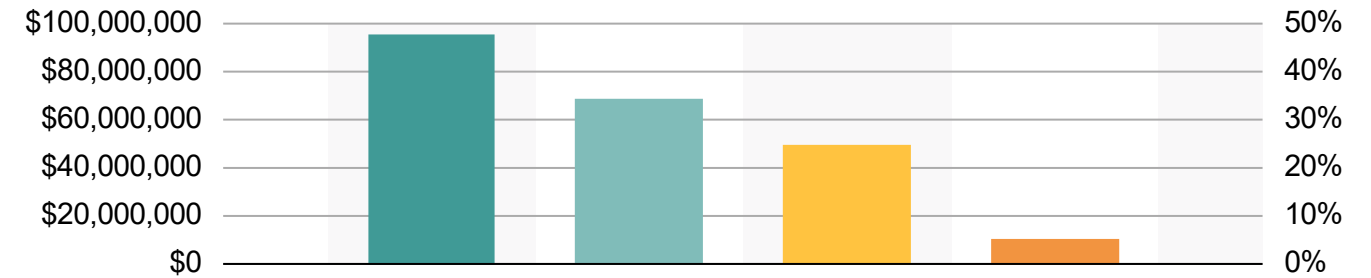

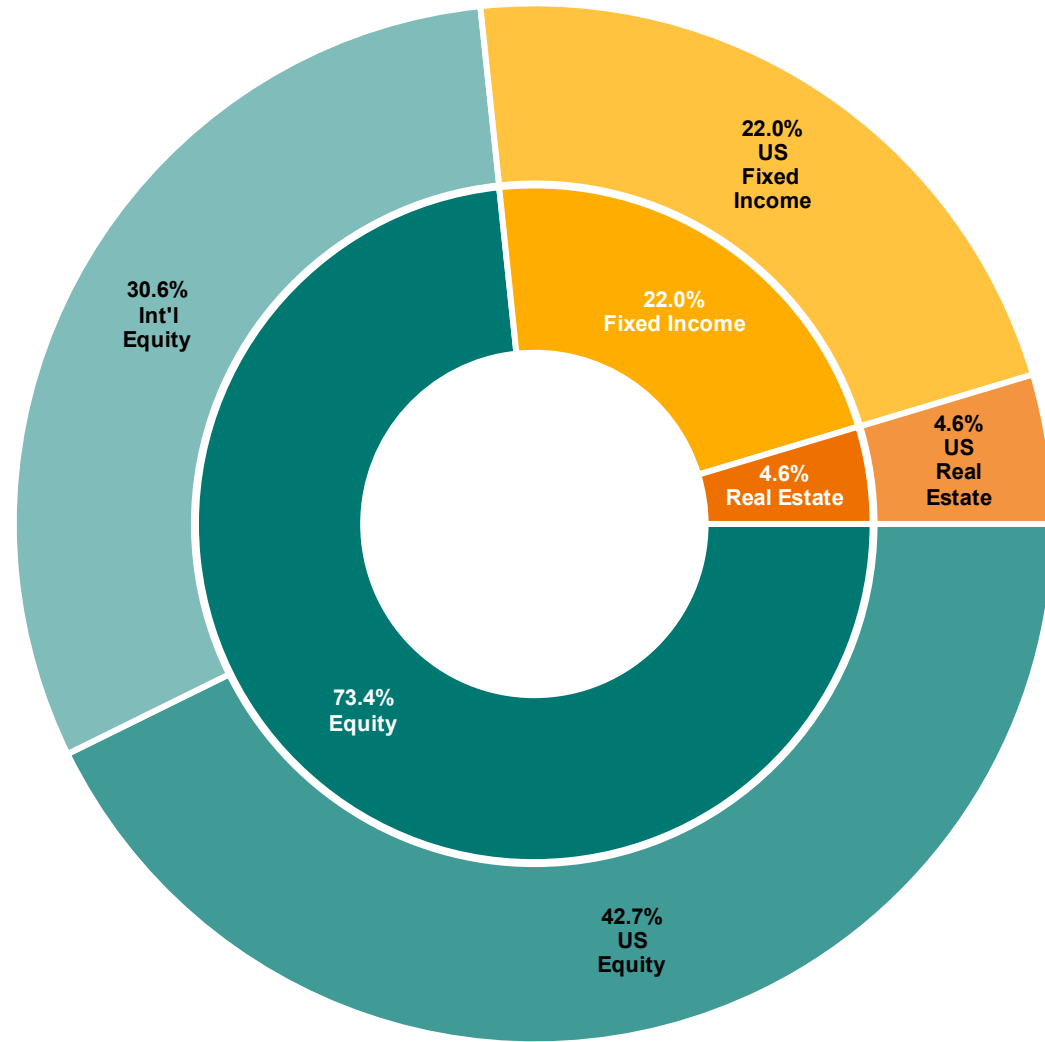

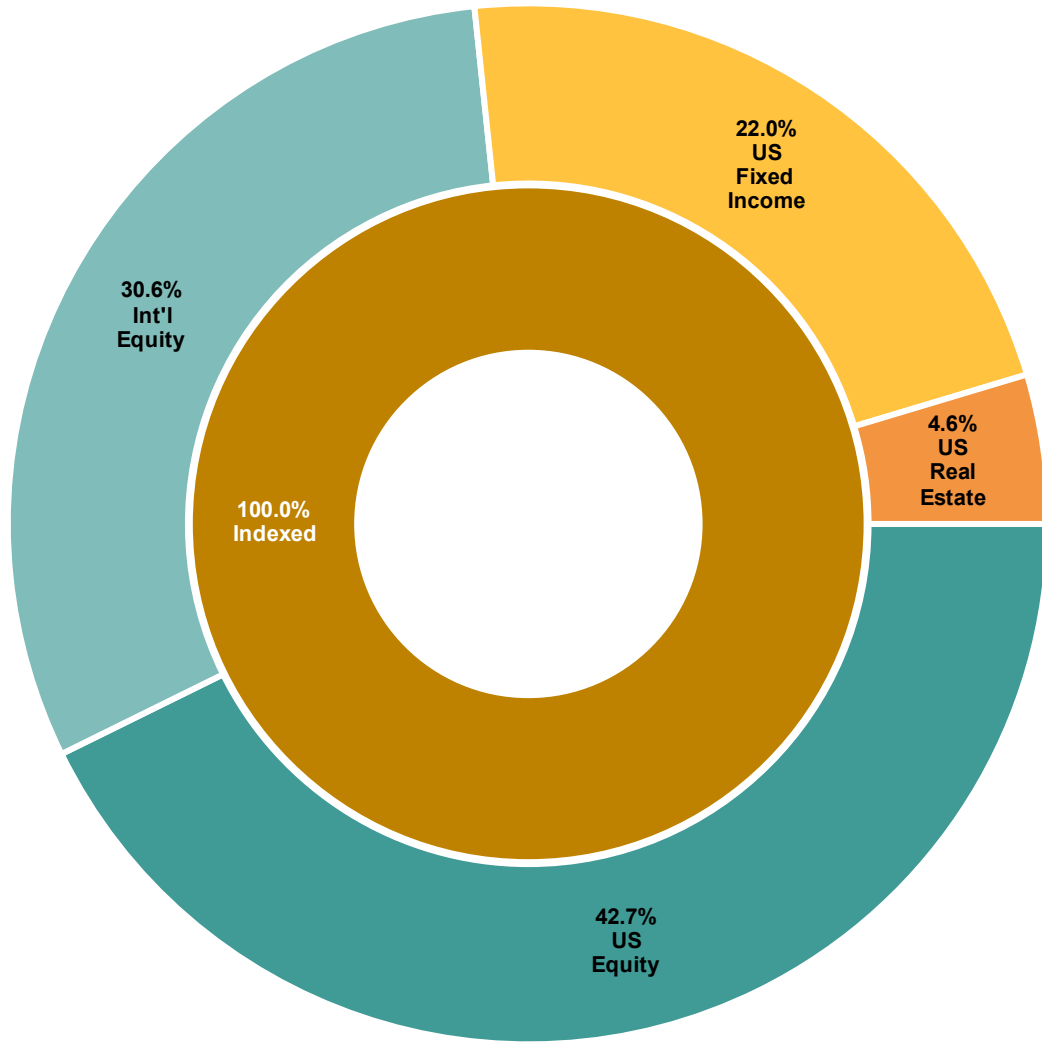

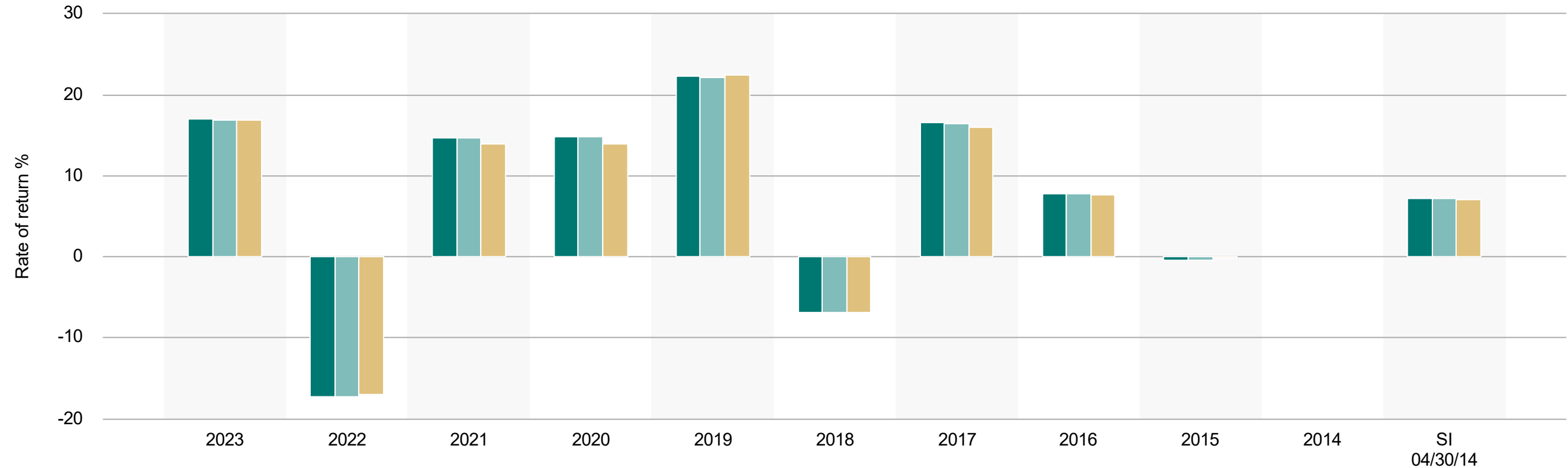

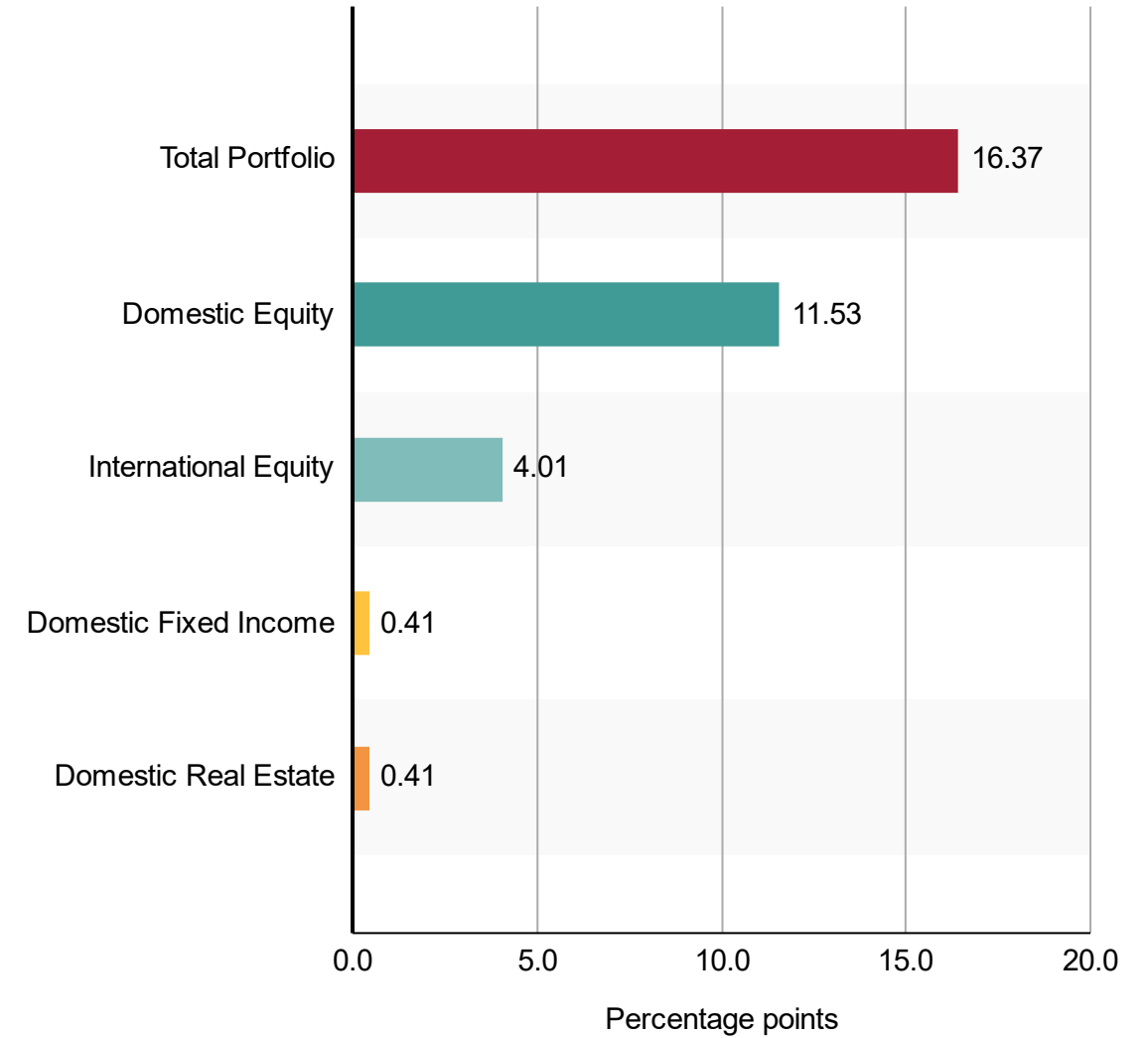
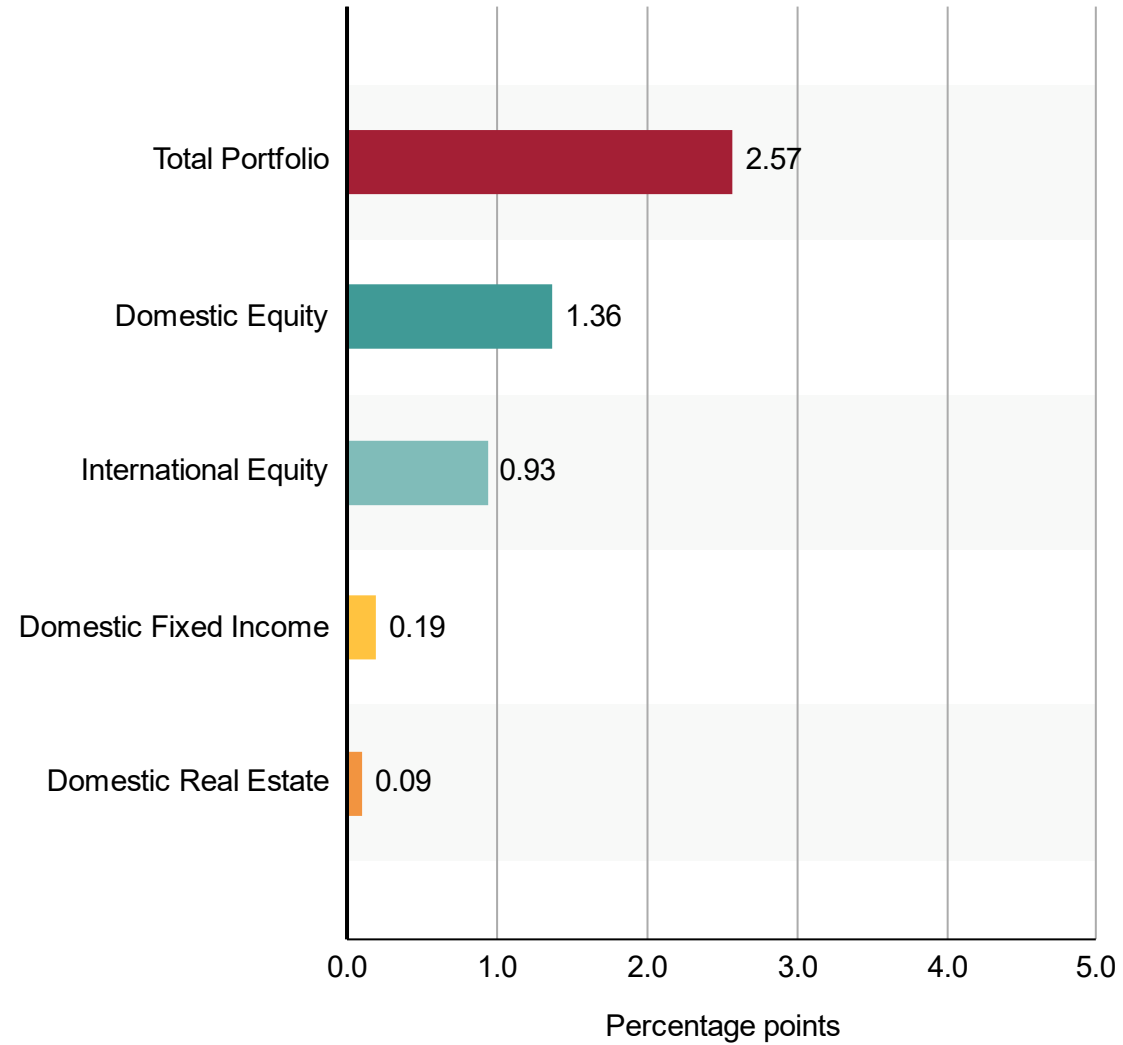
Asset-weighted contributions to performance

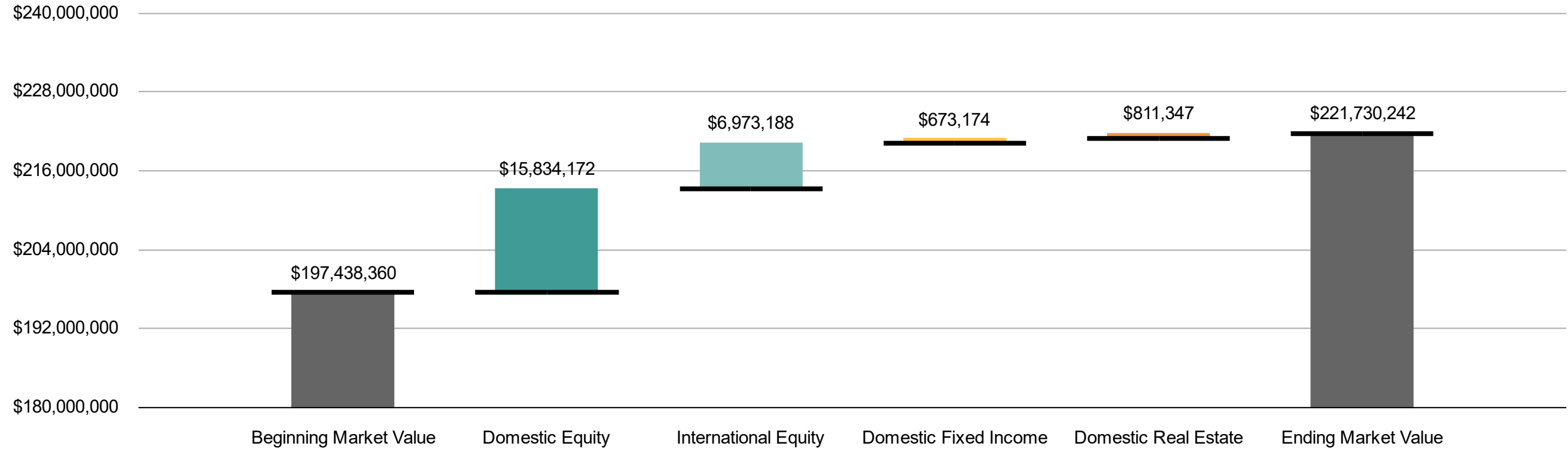

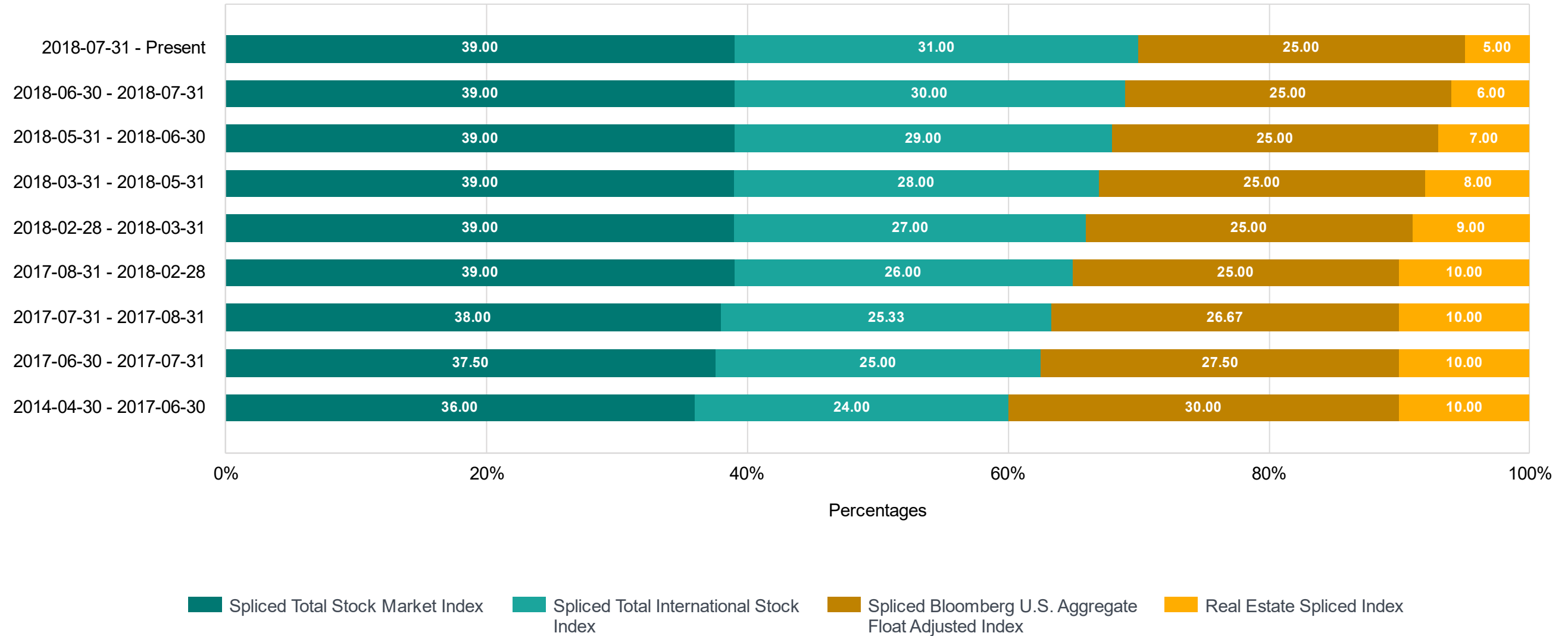
