The following outlines our privacy policy:

- We recognize that providing us with your personal information is an act of trust. When you visit the Community Foundation for Muskegon County online, you remain anonymous, as we do not require registration to view our website or access information.
- We may occasionally ask for your feedback via surveys or other communications to better understand your interests and needs. We will also request information through online forms used to register for a Community Foundation event or request use of our conference facilities. The Community Foundation does not share or make public any personal information gathered through our website.
- If you are a Community Foundation for Muskegon County fund holder and you use our online system, you provide personal information to authenticate your identity. That

information is only used on this site and is not distributed or sold to any other party or site.

- We will protect personal information by reasonable security safeguards against loss or theft, as well as unauthorized access, disclosure, copying, use, or modification. The Community Foundation utilizes a fully cloud-based solution hosted by Amazon Web Services (AWS). It used the highest standards for data security. Data in the AWS network is encrypted and hosted at secure data centers. Confidential payment data is not processed or saved on the system.

We are committed to conducting our business in accordance with these principles to ensure that the confidentiality of personal information is protected and maintained.
